The Commission requested that the Town Clerk contact all of the Commissioners to set up a date for the bus trip.

Marina Pro Forma

Mark Bolchoz and Rob Sims from Applied Technology & Management (ATM) gave a power point presentation of the Lake Park Marina. See exhibit "B".

Mayor Castro suggested that the administrative fee be placed into a special account for the first few years. Commissioner Jeanine Longtin agreed that it was a good idea.

Vice Mayor Chuck Balius does not want the taxpayers to have to cover the administrative oversight cost of the marina.

Commissioner Jeanine Longtin disagrees with the estimated cost of the fueling system. She does not believe that the due diligence has been done and the cost will be between \$800,000 to 1,000,000 not \$180,000.

Mr. Bolchoz explained that he had talked to Florida Petroleum and Fuel Components to arrive at the cost.

Commissioner Bill Otterson stated that he had driven around with Paul Carlisle and looked at various marinas and he feels that the estimate is an appropriate one.

Vice Mayor Chuck Balius stated that he would like to see suggestions for a marina flag.

Commissioner Paul Garretson stated that he would like to see a marina store and a restaurant for all to enjoy whether they have a boat or not.

The Commission stated that they would like Mr. Carlisle to get estimates from professionals who put in fuel systems.

The following persons addressed the Commission: Diane Munroe who stated that she is not against the price increases but she would like more boat ramps for the citizens to use. Jim Knox stated that there is a waiting list for the Marina already. Ed Daly asked if it would be possible to build the dock masters office right away.
